There are no changes to the program other than adding a new delivery method (100% online) which is explained below. The USC Columbia BA in Liberal Studies is coordinated through Palmetto College; however, the degree is conferred through USC Columbia.

USC Columbia plans to add the possibility of completing the BOL degree 100% online. Currently the degree can be offered in a blended format delivery, but some students, (e.g. deployed military personnel) cannot attend courses in person. Support for faculty, instructional technology support, and network capacity are already in place and no additional costs are anticipated.

All courses needed to complete this degree are currently available by distance learning. An academic advisor would steer an online student through the curriculum, starting with the Carolina CORE courses. In each area of the CORE, online courses are available and regularly offered. ENGL 101 & 102 meet the requirements of the communication and writing area (CMW). Students typically take the SPCH 140 in order to meet the spoken communication component (CMS). Both Spanish and Latin are offered online for the multicultural understanding component (GFL). The analytic and reasoning and problem solving (ARP) can be met in several ways that are offered online, including computer science and math classes. There are several sciences (SCI) offered online, including biology, chemistry, and environmental studies. The aesthetic interpretation component (AIU) can be met online in several ways, including American literature. Several online history courses can be taken to meet the historical thinking requirement (GHS), and online psychology, sociology, or anthropology courses are regularly offered online that meet the social science requirement (GSS). Several courses, including American government and contemporary moral issues are offered online that meet the values, ethics, and social responsibility requirement (VSR). An introduction to philosophy (PHIL 102) is also offered online that meets the special requirement of the degree.

After the CORE, a student would be advised through the major requirements that include South Carolina studies (PALM 493), service learning (PALM 495) and at the end of the program, a senior capstone course (PALM 401). All are offered online. Major courses (27 credit hours from two disciplines out of 25 possible disciplines) are at the 400 level and above. As an example, a student might choose political science and psychology as the two disciplines from the Social/Behavioral Sciences, or history and English from the Arts/Humanities. The student would take five courses from one discipline and four from the other. There are numerous online choices from the list of upper level English, history, political science, and psychology courses at USC available to choose from that would allow a student to complete the degree online. Therefore, an advisor has little difficulty in offering a student an online path for degree completion.

Currently the degree can be offered in a blended format delivery, but some students, (e.g. deployed military personnel) cannot attend courses in person. All courses needed to complete this degree are currently available by distance learning.

After the CORE a student would be advised through the major requirements that include 27-30 credit hours of professional foundation courses, all of which are offered online. These courses include economics, business writing, management, industrial psychology, leadership, elementary statistics for sociologists, computer applications in business, SC studies, and a service learning course.

Finally, a student would be advised through 33 credit hours of integrative major courses chosen from three areas, almost all courses of which are again available online. The student must take at least three courses from each area, including at least four courses at the 400 level or higher. In the area

entitled "Employer and Employees", 8 of the 10 courses are available online, including upper level management, psychology, and sociology courses. In the area entitled "Law, Policy & Organizations", 9 of the 11 courses are available online, including upper level accounting, management, history, and political science courses. In the area entitled "Workplace Dynamics", 10 of the 12 courses are available online, including upper level courses in economics, political science, and sociology. So a student looking for a total of eleven courses to choose from in the integrative major has twenty-seven options, all offered online. Therefore, an advisor has little difficulty in offering a student an online path for degree completion.





Nearly all of the courses offered by the Integrated Information Technology (IIT) department have been approved for online delivery and have been routinely taught online. To make this change, we have had to ensure that students could satisfy the program requirements only by taking online classes, which has recently been completed. Therefore, it is possible to take all the required courses to complete the program online.

The UofSC campus uses Blackboard as its online Learning Management System. This LMS allows online access to course material, tests, and grades. The UofSC is a Microsoft site, and as such we have available Teams Collaboration software which permits online screen sharing, and collaboration between groups. This tool can be used both to teach class, provide student support as needed, and allow student – student interaction. In addition, the IIT department manages an online networking lab funded by the NSF (National Science Foundation), which allows us to provide virtual networking assignments used in multiple classes. This system is currently be accessed remotely by other institutions across the US to teach their courses. The university also operates a technology support office. Students, staff and faculty can call in for technical support, which is available from 8 am – 6 pm five days per week. Furthermore, library resources are available online; automated support is available at all times while librarians can be reached during normal business hours.
